I/my child will not consume any alcoholic beverages or any other substance which would impair my senses prior to using or while using the facilities of IRCC.

When climbing at the wall, I/my child will wear a climbing harness for which I/my child assume all responsibility for putting on and fastening correctly and safely, and I/my child will always tie into the rope with a figure eight follow through knot for which I/my child assume all responsibility for tying correctly and safely, and I/my child will be belayed while climbing.

I assume full responsibility for my/my child's choice in belayers. The IRCC attempts to provide safe ropes, anchors and belay devices but will not be responsible for poor judgement by an ill-chosen belayer.

I/my child will belay only when knowledgeable and experienced at belaying.

I assume full responsibility for my/my child's personal belongings and will not hold the IRCC responsible for lost or stolen personal belongings.

I have read and fully understand the above and hereby waive and release any liability relating to climbing at the wall, I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, hereby release and hold harmless IRCC, their executive, and/or club members, other participants, and owners of the premises used for the activities, with respect to any and all injury, disability or death, whether caused by the negligence of the releasees or otherwise.
